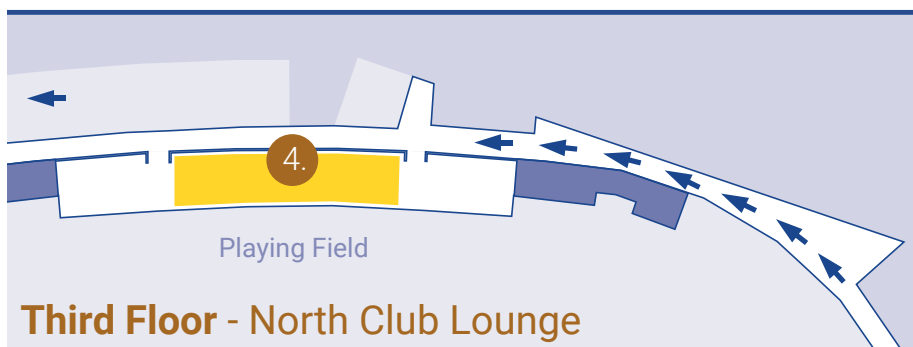
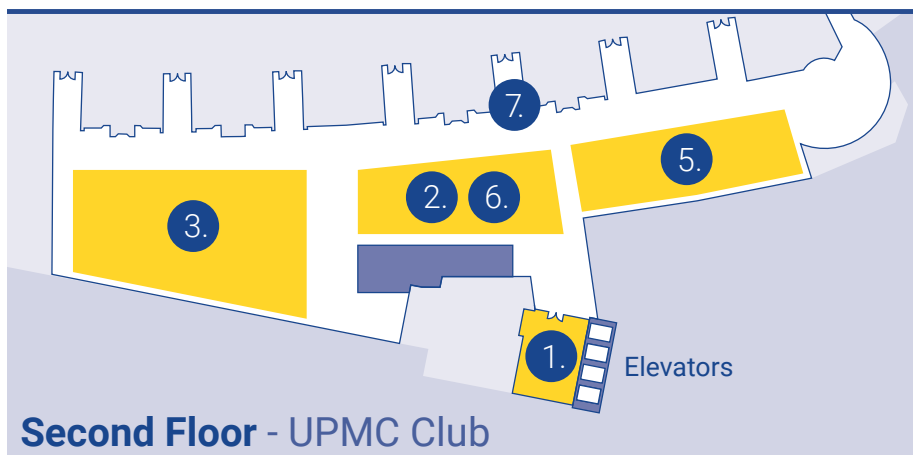

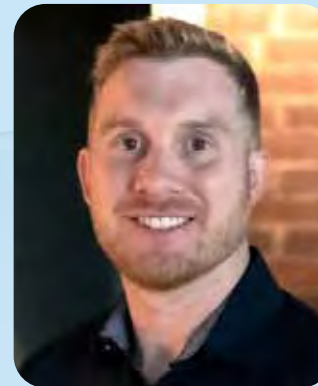
**Joseph C. Eddy**
